SUBMISSION INSTRUCTIONS

- Please print your name, dealer/member number, if you have one, return shipping address, email address and phone numbers in the spaces provided.
- Package Information (required) – Be sure to completely fill out this information.
- List each coin's, medal's or token's (hereinafter and hereinbefore referred to as "COIN" or "COINS") description separately on each line. For multiple coins of same date, denomination, and variety, list these separately one coin per line. List the date, denomination, and country of each coin. List Grading Company and Certification Number. Indicate Declared Value for each coin. If no value is assigned, you authorize WINGS to assign a \$50 value per coin. (Note: "P"= PCGS; "N"= NGC; "I"= ICG; "A"= ANACS and "C" = International Coin Certification Service)
- Select type of service level desired. **ONLY ONE TYPE OF SERVICE LEVEL IS PERMITTED PER SUBMISSION FORM.**
- Select SERVICE LEVEL by referring to the WINGS Services and Fees on the front.
- Calculate Fee, Handling Fee and Shipping Fee (rate chart above). There is a \$10 (ten dollars) Handling Fee for each Submission Order Form. You must remit return shipping fee for EACH unless you have your own shipping account. **IF YOU USE YOUR OWN SHIPPING ACCOUNT, PLEASE COMPLETE FRONT SIDE OF FORM.** There is a \$5 Alternate Return Carrier fee per Submission Order Form. **SHIPPING CHARGES ARE SUBJECT TO CHANGE DUE TO INCREASES IN SHIPPING RATES. THE CUSTOMER AUTHORIZES WINGS TO CHARGE ANY INCREASES IN SHIPPING CHARGES AND INSURANCE WHICH ARE GREATER THAN THOSE THAT APPEAR ON THIS FORM.** There are No drop offs or pick-ups orders at WINGS other than at coin shows, to authorized WINGS dealers or as may have been previously arranged with WINGS. WINGS in its sole discretion shall choose the shipping carrier and insurance company.

- Package coins and submission forms carefully.
- Ship via U.S. Mail (registered, insured) or USPS Express Mail to WINGS, P.O. Box 271510; Tampa, Florida, 33688-1510. Packages to WINGS must be insured. For alternate shippers used by you, call Customer Service. and those that appear on our website and the most current. Estimated turnaround times do not include mailing time and reflect business days, and are just estimates.

TERMS AND CONDITIONS

By signing the front of this form, Customer acknowledges having read the Terms and Conditions set forth herein and agrees to abide by this Agreement.

- WINGS will endeavor to verify coins within the time frame, if any, offered as part of WINGS' verifying service. However, WINGS will have no liability whatsoever to Customer for incidental or consequential damages due to WINGS' failure to verify any coin within any time frame. All days are business days and all estimates are just estimates. WINGS shall place a gold sticker on the holder of any coin that WINGS, in its sole and absolute opinion and discretion, determines is premium quality within the assigned grade or a silver sticker if WINGS determines that it is a "solid for the assigned grade" designation.
- WINGS will only verify coins that are submitted in NGC, PCGS, ICG, ANACS or ICCS holders. If Customer submits coins that are not in one of these company's holders, the coins will be returned at the Customer's expense.
- Verifying involves individual judgments that are subjective and require the exercise of professional opinion, which can change from time to time. Therefore, WINGS makes no warranty or representation and shall have no liability whatsoever, in any manner, to Customer for the issuance or non-issuance of a WINGS sticker.
- WINGS will exercise reasonable care in handling coins submitted. However, if WINGS determines that the Customer's coin(s) was lost or damaged while in WINGS' possession, Customer will be compensated based upon the fair market value of the coin as determined by WINGS' standard procedures which may include filing a claim with our insurance carrier. The declared value you stated on the front of this form is for estimating the insurance coverage only and the fair market value of the coin may in fact be less than or more than your declared value. **IN NO EVENT SHALL WINGS' TOTAL LIABILITY EXCEED THE DECLARED VALUE OF THE COIN AS DETERMINED BY YOU.**
- Customer must inspect all coins immediately upon receipt and WINGS disclaims any liability for damage or discrepancies or errors unless reported to WINGS within three (3) calendar days of Customer's receipt of the coin(s).
- Customer agrees (a) to pay WINGS all fees and other charges when due; (b) that any delinquent balances shall accrue interest at the rate of 18% per year until paid (or, if less, the maximum interest rate permitted by applicable law); and (c) that WINGS shall have a security interest in the coins submitted, as well as in any other property of Customer in the possession of WINGS or its affiliates (collectively the "Property") to secure payment thereof. Customer hereby grants to WINGS an assignment of and lien against the Property in the amount of any fees and other charges due and payable pursuant to the terms of this Agreement. Customer hereby authorizes WINGS to file, at any time on or after the date such fees and other charges become due, appropriate uniform commercial code financing statements in such jurisdictions and offices as WINGS deems necessary to perfect a security interest in the Property.
- WINGS shall have no liability whatsoever to Customer, or any third party for whom Customer may be acting for (i) any personal injury or (ii) for any damage to any coin, or otherwise, that Customer is unable to demonstrate was attributable primarily to an act or omission to act by WINGS while the Property was in WINGS' physical possession and physical control.
- Note all terms and conditions are subject to change. Turnaround times do not include mailing time and reflect business days and are merely estimates.
- Except as expressly set forth herein to the contrary, **WINGS DISCLAIMS ANY AND ALL WARRANTIES, EXPRESSED OR IMPLIED REGARDING WINGS' GOODS AND SERVICES, INCLUDING BUT NOT LIMITED TO THE WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.**
- Notwithstanding anything to the contrary contained herein, except for verifying, THE MAXIMUM LIABILITY THAT WINGS SHALL HAVE TO CUSTOMER, OR ANY THIRD PARTY FOR WHOM THE CUSTOMER MAY BE ACTING, ARISING FROM ANY CAUSE, ACT, OMISSION OR OTHER CIRCUMSTANCE, SHALL IN NO EVENT EXCEED THE FEE OR LESS ACTUALLY PAID BY CUSTOMER FOR THE SERVICES RENDERED BY WINGS WITH RESPECT TO THE COINS SUBMITTED FOR VERIFYING HEREUNDER. IN NO EVENT SHALL WINGS OR ANY OF ITS AFFILIATES OR ANY OF ITS OR THEIR RESPECTIVE EMPLOYEES, OFFICERS, DIRECTORS OR AGENTS, BE LIABLE TO CUSTOMER OR ANY OTHER PARTY FOR ANY INDIRECT, INCIDENTAL, SPECIAL CONSEQUENTIAL OR EXEMPLARY DAMAGES, EVEN IF ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.
- In the ordinary course of its operations, WINGS (i) compiles data regarding each coin submitted for verifying, including, but not limited to, data relating to the identity, minting, condition and grade of the coin (the "Data"); and (ii) may take, or have taken, one or more digital or other types of photographs, images or reproductions of each such coin (collectively the "Images"). In consideration for the services being provided by WINGS, Customer, on behalf of him/her self and/or any third party, hereby authorizes WINGS (i) to compile and maintain such Data with respect to each coin submitted hereunder, and (ii) to take or cause to be taken, one or more images of each coin and further agrees that WINGS will be the owner of such Data and all such Images and that WINGS may use and exploit such Data and the Images for commercial and any other purposes as WINGS in its sole discretion deems appropriate including but not limited to the publication, republication or reproduction in or on any media of such Data and Images. Without limiting the generality of the foregoing, Customer on its behalf and/or any third party for whom Customer may be acting with respect to this Agreement unconditionally and irrevocably transfers, conveys and assigns to WINGS any and all current and any hereafter acquired rights, title and interests (including without limitation rights in copyright, patent, trade secret and trademark) that Customer or any such third party may have in or to the Data and the Images (on whatever media or in whatever form such images may be reproduced or published).
- If any coins are being submitted for a third party, Customer represents and warrants that such third party has agreed and accepted this Agreement and had signed a duplicate copy hereof. Customer agrees to provide that third party-signed copy to WINGS at any time upon request. Customer further agrees to indemnify WINGS for any damages incurred by the third party.
- This Agreement is delivered and accepted in the State of Florida and it is the intention of the parties that it be governed by and construed in accordance with the substantive laws of that State, without regard to conflicts of laws principals. The parties hereby consent to personal jurisdiction of the courts of the State of Florida with respect to any legal action to enforce the terms and conditions of this Agreement or otherwise arising under or with respect to this Agreement, and agree that the Circuit court of Florida, County of Miami-Dade, or if applicable, federal District Court sitting in the County of Miami-Dade, State of Florida shall be sole and exclusive venue and forum for the bringing of such action. Each of Customer and WINGS agrees that the prevailing party shall be entitled to its reasonable attorney's fees, costs and expenses.
- The Terms and Conditions in this Agreement constitute the entire agreement of WINGS and Customer (and any third party for whom Customer may be acting) regarding, and supersede all prior agreements and understandings (written or oral) between or among such parties relating to the subject matter hereof. If any term or provision in this Agreement is determined by a final and non-appealable ruling or order of a court of competent jurisdiction, to be invalid or unenforceable under applicable law, such invalidity or unenforceability shall not affect the validity or enforceability of any of the other of the terms or provisions of this Agreement. Each party shall execute and deliver such additional documents and instruments as any other party may request to better evidence or effectuate the agreements contained herein, including the assignment of rights set forth in Section 11, and procedures, and further agree that WINGS is entitled to rely upon and benefit from those terms and procedures.
- All references to "WINGS" shall mean WINGS COINS, LLC, a Florida limited liability company. All references to "Customers" shall include dealers, auction companies and any other person or entity submitting this submission form. All references to "Agreement" shall mean this Submission Form in its entirety as may be updated from time to time on our website. "Card" shall mean a credit card or a debit card, as the case may be.
- Credit Card Approval and release. "I the submitter named on the front of this Submission Form, authorize WINGS COINS, LLC (WINGS) to charge the card account I provided for the amount of the total charges on the front of this Submission Form upon receipt of my request for verifying services including any increases in shipping fees that may then be in place even though this form does not accurately reflect said shipping charges. I acknowledge that by completing and signing this Submission Form that I agree to pay WINGS the full amount of the requested fees and other charges on the card number I provided regardless of the final verifying opinion provided. I understand that if I disregard this provision, I shall be subject to immediate discharge from WINGS Authorized Dealer Membership, if applicable, and loss of all rights and entitlements therein. I also agree that if a dispute arises in regard to the verifying services rendered my remedy is to give written notice to WINGS within 5 days of receipt of said verified items with notification by e-mail, fax or certified US mail, return receipt requested, and with my consent, I understand that WINGS reserves the right to post additional charges to my credit card account if extra or different services are required to fulfill requested services."
- In addition to credit cards and money orders, WINGS will accept personal checks. WINGS shall perform no services until the check has cleared. After the check has cleared, WINGS shall then commence the verifying process pursuant to the service level chosen on the front of this Agreement. In the event that the check does not clear for any reason, then the submitter shall be charged a fee of \$30. Until such time Customer agrees that WINGS may retain Customer's coin(s) until the \$30 fee is paid.
- All orders are F.O.B. WINGS' location. Customer is responsible for all shipping costs and if it pays the fee then for selecting an alternate carrier. All risk of loss shall pass to Customer upon WINGS' delivery to the carrier.
- A WINGS' sticker does not increase the value of the submitted item(s). The value is set by the market and not by WINGS.
